CONNECTING

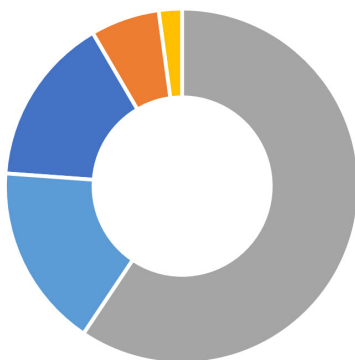
